- xiii. Call Records of interaction with Naadee Health representatives, business partners and contractors,
- xiv. Tele / Video Archives for Tele / Video consultation as applicable,
- xv. Your usage details such as time, frequency, duration and pattern of use, features used and the amount of storage used,
- xvi. Master and Transaction data and other data stored in Your user account,

Individual records of User data may be viewed or accessed only for the purpose of resolving a problem, support issues, or suspected violation of the terms of use, or as may be required by law. We would take all reasonable precautions for maintaining confidentiality of data.

7.2 Your Personal Information may be used for various purposes including but not limited to the following:

17.2 As part of the registration/application creation and submission process that is available to Health Partners on Website, certain information, including sensitive personal data or information is collected from the You.

17.3 All the statements in this privacy policy apply to all Health Partners, and all Health Partners are therefore required to read and understand the privacy statements set out herein prior to submitting any sensitive personal data or information to Naadee Health, failing which they are required to leave the Website or App immediately.

17.4 Health Partners personally identifiable information they choose to provide on the Website or App is used to help the Health Partners describe / identify themselves. This information is exclusively owned by Naadee Health. Naadee Health may use such information for commercial purposes and in an aggregated or non-personally identifiable form for research, statistical analysis and business intelligence purposes, and may sell or otherwise transfer such research, statistical or intelligence data in an aggregated or non-personally identifiable form to third parties and affiliates.
